Introduction

The tennis club lease an area of land on the playing fields from C&SPPFA Ltd. The tennis club is a private club, for members only, though at times certain courts can be hired out to the public, via the Lawn Tennis Association, Clubspark booking system. The tennis club consists of six astro-turf tennis courts, with flood lighting, and a small clubhouse. The tennis courts and clubhouse are separated from the playing fields by tall fences, and there is no access to the general public. The tennis club's lease allows members to park in the Village Hall car park, and access the tennis club, across the playing fields. The tennis club have their own rules and risk assessments in place, relating to people using the tennis courts and the clubhouse, in a safe and responsible manner. These documents are updated regularly and are available to the C&SPPFA Ltd on request.
